Prior to joining the firm, *Jaimie* served as an Assistant U.S. Attorney for the Southern District of New York in both the criminal and civil divisions and later chaired the White Collar, Investigations, and Compliance Practice Group at Kelley, Drye, & Warren. She has successfully led complex civil and criminal fraud trials and advises individuals and companies in investigations and actions by the DOJ, SEC, CFTC, and state regulators. *Philip* served as Senior Counsel in the SEC's Division of Enforcement for more than a decade prior to joining the firm in 2019. Philip advises investment managers on regulatory compliance risks and challenges, including issues related to insider trading or the potential misuse of MNPI, onboarding alternative data and other research providers, ESG products, valuation, fees and expenses, conflicts of interest, and whistleblowers. He represents companies and individuals in SEC investigation or undergoing SEC examinations. He also advises clients on securities law issues related to cryptocurrencies, NFTs, and DeFi solutions.

Michael served as both a federal prosecutor in the U.S. Department of Justice (DOJ) Tax Division and as Senior Litigation Counsel in the Enforcement Department of the Financial Industry Regulatory Authority (FINRA) and later was partner at King & Spalding LLP. He advises broker-dealers, investment advisers, accounting firms, and other market participants in regulatory matters involving a wide range of accounting, tax, and securities issues. He also regularly conducts regulatory due diligence on wealth management-related mergers and acquisitions. *Russell* served as a Senior Counsel in FINRA's Department of Enforcement and later as a partner in King & Spalding's Special Matters and Investigations Practice. He's handled matters on both sides of the table related to securities fraud, insider trading, market manipulation, sales practices, financial crime compliance, trade reporting, and the use of digital assets. He regularly represents financial institutions and individuals on an array of regulatory matters and investigations involving the DOJ, SEC, CFTC, FINRA, and NYSE.

Casey served as Counsel in the Consumer Financial Protection Bureau's Office of Regulations for four years prior to joining the firm. Casey advises financial institutions, including banks, broker-dealers, investment managers, and "FinTech" firms, on regulatory issues related to consumer protection, data privacy and cybersecurity, anti-money laundering, payments, and myriad bank regulatory issues (including deposit regulations and the Volcker Rule).
